- A. SONWEST CO., a Texas corporation ("Declarant") previously executed that certain: (i) <u>Declaration of Condominium Regime for Sonterra I Condominiums</u>, recorded under Document No. 2016002134, Official Public Records of Williamson County, Texas, as amended (the "Declaration"); and (ii) <u>Community Manual for Sonterra I Condominiums</u>, recorded under Document No. 2016031139, Official Public Records of Williamson County, Texas (the "Community Manual").
- B. Pursuant to Section 1.12 of the Declaration, the Community Manual may be amended, from time to time, by a majority of the Board; provided, however, that during the Development Period (as defined in the Declaration), any amendment to the Community Manual must be approved in advance and in writing by the Declarant. The Development Period has not expired, and Declarant has approved this Amendment as evidenced below.

 - D-5 <u>Fireworks Prohibited</u>. The display or discharge of fireworks on the Property is prohibited.
 - H-6 <u>Trailers</u>. Trailers shall be kept at all times, except when in actual use, in enclosed garages or otherwise screened from view. No trailers shall be parked or placed on any street right of way, driveway, or used as a residence, either temporary or permanent, at any time.
- 2. <u>Miscellaneous</u>. Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Community Manual. Unless expressly amended by this Amendment, all other terms and provisions of the Community Manual remain in full force and effect as written, and are hereby ratified and confirmed.
